For and on behalf of Area Manager, Food Corporation of India Mayapuri New Delhi sealed quotations are invited from the interested financially sound parties, having business competency to carry-out the transportation work of food grain stocks and also having his/their own trucks fleet, for the appointment of **Mandi Transport Contractor Najafgarh Mandi** for Rabi Procurement Season 2010-11 i.e. w.e.f. 01.04.2010 to 30.06.2010 and further extendable for another 3 months at the same terms and condition as per Annexure A.

Transportation of Wheat/Gunny Bales/Crates/Tarpaulins/Polythene covers will be carried out as under: -

- 1) The tenderers should submit both the tender Bids i.e. "Technical Bid" and "Price Bid" in separate sealed envelopes and finally putting them in one sealed cover including Annexure A, duly filled in complete and signed on each page of the Annexure A.
- 2) All credentials, documents and copies of certificate/information called for should be submitted as per tender terms with "Technical Bid" in one stroke as detailed below: -
  - i) Income Tax clearance certificate for the preceeding two years
  - ii) Partnership deed in case of partnership concerns.
  - iii) Documentary evidence for financial soundness
  - iv) Experience Certificate.
- 3) Technical Bid shall be accompanied by earnest money of Rs. 10,000/-(rupees ten thousand only) by Demand Draft OR Pay Order of any scheduled bank in favour of Food Corporation of India, Mayapuri, New Delhi.

- 4) The name of work and words "Technical Bids" only and " Price Bid" only, as the case may be, should be clearly written on top of respective (cover) envelopes.
- 5) The technical bids only shall be opened first on 18.02.2010 at 02.00 PM in the presence of the tenderers or their authorized representative who will remain present. The price bids of only those tenderers shall be opened whose technical bids are found to be prima-facie acceptable. The time and the date of opening of price bid is 18.02.2010 at 3.00 PM. The successful tenderer of Price Bid has to deposit Rs. 5000-00 ( Rupees five thousands only ) by **cash or by demand draft** in favour of Area Manager FCI Mayapuri as **Security**.
- 6) It should be clearly understood by the tenderer that no opportunity shall be given to them to alter, modify or withdraw any offer at any stage after submission of the offer.
- 7) The quotations i.e. "Price Bid" should be on letter Head dealing with the Mandi transportation work and must be accompanied with Annexure A duly signed by the Proprietor(s) of firm and/or his/their authorized representative and the rates to be quoted/offered should be on weight basis i.e. rates per quintal for each center.

**TERMS & CONDITIONS FOR MANDI TRANSPORT CONTRACTOR**

Successful tenderer will be required to transport foodgrains procured in the Mandi and other items i.e. gunny bales etc. from Mandi to Depot and vice-versa. If required in the exigencies of work, the contractor shall be bound to work on closed holidays (including Sunday). The Corporation do not guarantee any definite volume of work during the currency of the contract Area Manager may terminate the contract prior to the expiry of the period of the contract without assigning any reason and no claim shall lie against the Corporation for such earlier termination of the contract.

The contractor will be responsible for the safety of foodgrain etc. while in transit in their trucks. They shall be liable to make good the value of shortage, wastage, loss or damage to the foodgrains in transit on the basis of double value of central issue price.

Tenderers are required to attach the following documents in the envelope marked **“Technical Bid”**

- 1) Income Tax clearance certificate for the preceeding two years.
- 2) Partnership deed in case of partnership concerns.
- 3) Documentary evidence for financial soundness
- 4) Experience certificate.
- 5) Demand draft / Pay order of Rs. 10000/- ( Rs. Ten Thousands only) as earnest money.

In case the Income Tax clearance certificate cannot be furnished for some reason along-with the tender, an undertaking to furnish the same within 15 days of date of submission/acceptance to the tenders may please be furnished.

Simultaneously the tenderers are requested to disclose the name of their bankers.

The “Price Bid” of only those tenderers shall be opened whose “Technical Bid” are found to be prima facie acceptable. The successful tenderer of Price Bid has to deposit Rs. 5000-00 ( Rupees five thousands only) **by cash or by demand draft** in favour of Area Manager FCI Mayapuri as **Security**.

Tenders will remain open at D.O. Mayapuri for acceptance up to and inclusive of 18.02.2010 upto 1:00 PM. Area Manager, Food Corporation of India, Mayapuri, New Delhi may at his discretion, extend this date by a fortnight and such extension shall be binding upon the contractors.

Area Manager, FCI Mayapuri, New Delhi reserves the right to accept/reject, all/any tender without assigning any reason. The contractors may be required to make adequate arrangement of trucks etc. If the contractor fails to provide requisite number of trucks, the Corporation would be at liberty to get the work done at his risk and cost and contractor shall be responsible to compensate FCI for the extra expenditure incurred by FCI, losses/damages sustained by FCI, Mayapuri, New Delhi due to failure of the contractor to supply the adequate number of trucks. The decision of Area Manager, FCI Mayapuri, New Delhi in this regard shall be final and binding upon the contractors.

The tenderers will be bound by the terms and conditions of short-term notice for the transport contract work.

In the event of contractors failure to discharge his/their duties and responsibilities efficiently and in a unworkman like manner, the Area Manager, FCI Mayapuri, New Delhi reserves the right to forfeit the earnest money which will be kept as security deposit on acceptance of tender and get the work done at their risk and cost during the unexpired period of the contract. The decision of Area Manager, FCI Mayapuri, New Delhi shall be final and binding upon the contractors in this regard.

Tenderers in their own interest are advised to visit the concerned Mandi/Depots to acquaint themselves with the type/nature of the work before submitting the tenders.
