

**Minutes of the meeting for sale of wheat under OMSS(D) Bulk through e-tendering on 16.6.2010 between 1000 hours to 1150 hours**

- 1) As per the Press Release, 10,000 MT of wheat each from FSD-Narela, Mayapuri and Ghevra was earmarked for release in the market against the balance unsold quantity of about 70,000 MT, valid for lifting upto 30.6.2010.
- 2) FCI had quoted sell orders of 5,000 MT each from the Depots of Narela, Mayapuri and Ghevra. While, as the buy orders were received for a quantity of 750 MT (550 MT from FSD-Narela, 100 MT from FSD-Mayapuri and 100 MT from FSD-Ghevra).
- 3) The quotes received were as follows :-

- 5) The stocks will be issued to the buyers subjected to the receipt of EMD from the Exchange on date.
- 6) The prevailing open market price of wheat in Delhi is ranging between Rs.1235/- to Rs.1252/- as on 15.6.2010. In-view of the quotes received for 750 MT during e-tendering on date, on NSEL Platform, it is recommended that the stocks will be released under OMSS(D) Bulk on weekly basis, on each Wednesday during a session from 1000 hours to 1150 hours till the remaining stocks are liquidated or end of June, 2010, whichever is earlier.




